## **ADDITIONAL TERMS FOR LONG TERM BOARDING**

**Fees and charges for long term care are due and payable each month on the 1st of each upcoming month with a prorated payment for 1st month due upon receipt of animal(s) to Auntie Linda's. Failure to pay fees and incurred charges and retrieve the animal(s) within 15 days of agreed upon pick up date or failure to pay monthly fees and incurred charges due by the 15th of each billed month will result in additional collection and late fees and may result in the immediate sale or disposition of the animal(s) without further notice to owner to recover monies owed.**
